ORDINANCE NO. 2018.10

A GENERAL ORDINANCE TO AMEND THE SOUTHPORT CITY CODE CONCERNING
SALVAGE TITLE FEES

WHEREAS, the Common Council (“Common Council”) of the City of Southport, Indiana, (the “City”), has by prior ordinance established Section 4.16.010 of the Southport City Code governing the Southport Police Department, Salvage Title Fees; and

WHEREAS, the Common Council desires to amend Section 4.16.010 to amend the fees to be collected for each vehicle processed;

NOW THEREFORE, be it ordained by the Common Council of the City of Southport as follows:

Section 1. Section 4.16.010 of the Southport City Code is hereby amended to read as follows:

(A) Whenever a police officer with the Southport Police Department performs an inspection of a salvage vehicle in accordance with Title 9 of the Indiana Code, a \$5 inspection fee shall be collected for each vehicle inspected. In the event the officer travels to a location other than the headquarters of the Southport Police Department to perform the inspection, an additional \$20 off-site service charge shall be collected as a reasonable charge for the expenditure of the Department’s resources and officer’s time to travel to the off-site location for the related inspection.

(B) The Police Department shall forward the inspection fee and the off-site service charge, if any, to the City Clerk-Treasurer, who shall deposit it into the Law Enforcement Continuing Education Fund.

Section 2. This Ordinance shall be in full force and effect after its passage and approval by the Mayor of the City of Southport, Indiana, or as otherwise provided by I.C. 36-4-6-14.
