AN ORDINANCE TO AMEND THE SOUTHPORT CITY CODE CONCERNING THE
PROCEDURE FOR THE ADOPTION OF ORDINANCES

ORDINANCE NO. 2018.07

WHEREAS, the Common Council (“Common Council”) of the City of Southport, Indiana, (the “City”), has by prior ordinance established Section 3.08.080 of the Southport City Code governing the Common Council’s procedure for adopting ordinances; and

WHEREAS, the Common Council desires to amend Section 3.08.080(B) to reduce the number of times an ordinance is required to be read before being passed by the Common Council;

NOW THEREFORE, be it ordained by the Common Council of the City of Southport as follows:

1) Section 3.08.080(B) of the Southport City Code is hereby amended to read as follows:

(B) All ordinances shall be read two times before being finally passed by the Common Council, but readings may be by title only. Introduction shall be considered first reading, and no ordinance shall be passed on the same day the ordinance is introduced except upon compliance with the provisions of I.C.36-4-6-13. On passage or adoption of any ordinance the yeas and nays shall be determined by the Mayor and entered into the record by the Clerk-Treasurer, and the ordinance shall be processed in accordance with I.C. 36-4-6-14 through 36-4-6-17.

2) This Ordinance shall be in full force and effect after its passage and approval by the Mayor of the City of Southport, Indiana, or as otherwise provided by I.C. 36-4-6-14.
