AMENDMENTS TO CHAPTER 10.12 – PARKING
ORDINANCE NO. 17.05.01

WHEREAS, the Board of Public Works & Safety of the City of Southport, Indiana (the Board) has considered and reviewed that there are streets within the City of Southport that should be added to the “No Parking” Municipal Code 10.12.020, and

WHEREAS, the Board has also determined the need to transfer Section 10.12.030 Method Generally for ease of location in Code and the enforcement thereafter.

NOW THEREFORE, The Common Council has agreed to the necessary additions and corrections as determined by the Board of Public Works & Safety of the City of Southport, Indiana as follows:

- A. No parking on the north side of Babette Drive from McFarland Road west and then northwest to the intersection of Simone Drive and Babette Drive.
- B. No parking anytime on the north side of South Street from Walnut Street on the east to Madison Avenue on the west.
- C. No parking anytime on the south side of South Street from Walnut Street on the east to West Street on the west.
- D. No parking anytime on the east side of Derbyshire Road from Southport Road on the south to the Buck Creek Bridge on the north.
- E. No parking on either side of Washington Street.
- F. No parking on the west side of Church Street from South Street on the north to the dead end on the south.
- G. No parking on either side of Main Street from 25 Main Street to Derbyshire Road.
- H. Section 10.12.030 Method Generally shall be moved to Section 10.12.010 and become number 18 (eighteen).
