ESTABLISHMENT OF COMMUNITY CROSSINGS GRANT FUND
ORDINANCE 2018.01

WHEREAS, the City of Southport has been awarded Community Crossings Grants to repair streets, sidewalks and install ADA ramps; and

WHEREAS, the City is required to provide local matching funds equal to not less than 25% of the estimated project costs; and

WHEREAS, the funds are to be accounted for separately from other City funds.

NOW THEREFORE the Common Council of the City of Southport establishes an accounting fund for the Community Crossings Grant and the transfer of funds as follows:

1. **Fund #710-** Community Crossings Grant Fund - for the receipt of any monies set aside specifically for the project from either local funds or other agencies and for the disbursement of monies upon approval of the Board of Public Works & Safety and City Council. This shall be a temporary fund, specifically for the project until it is completed and the Council has acted to bring the account to a zero balance. The disposition of any remaining funds at that time will be determined by their origin and Indiana Code pertaining to the origin of the said funds and their use.
2. The transfer of funds and appropriations for this first project are approved from 2018 appropriated funds as follows:
 - a. From Fund 706 (Local Roads & Streets) \$21,000.00 (Street Repairs Budget Line)
 - b. From Fund 708 (MVH) \$123,033.88
