AMENDMENT OF ORDINANCE 16.10.03 – 2017 ANNUAL COMPENSATION OF POLICE  
ORDINANCE NO. 17.01.01

---

- WHEREAS, the Common Council adopted Ordinance 16.10.03 – 2017 Annual Compensation of Police on October 17, 2016; and
- WHEREAS, that Ordinance included an Insurance Package for the Police Chief and Patrol Officer; and
- WHEREAS, the Police Chief has maintained health insurance through the Affordable Care Act and the new patrol officer is currently covered under his spouse's insurance; and
- WHEREAS, the new insurance will not go into effect until February 1, 2017; and
- WHEREAS, after review and advice from the State Board of Accounts and the city attorney, Andrew Wyrick on this matter, both advised amending the Salary Ordinance and taking the amount allotted for the "Insurance Package" and adding it to the "Police Chief Compensation".

NOW, THEREFORE, be it ordained by the Common Council of the City of Southport, Indiana as follows:

1. The Salary Ordinance 16.10.03 is amended so that the Police Chief's Salary for January 31, 2017 payroll is \$3,459.30 (1/24 of \$57,288.00 [annual salary] plus 1/12 of \$12,867.54 [annual insurance package]).
2. The Clerk-Treasurer is directed to transfer the \$1072.30 from the Insurance – Health line of the 2017 budget to the Police Chief Salary line.
