AMENDMENT TO CHAPTER 10.20 SPEED LIMITS AND REGULATIONS

ORDINANCE NO. 16.08.01

---

WHEREAS, a review of Chapter 10.20 of the City of Southport Municipal Code has been conducted; and

WHEREAS, it has been determined that updates and clarifications are warranted.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SOUTHPORT, INDIANA AS FOLLOWS:

1. Repeal sections 10.20.060 – Twenty-five Miles Per Hour Areas, and 10.20.070 – Forty Miles Per Hour Areas
2. Replace 10.20.040 – title “Twenty Miles Per Hour Areas” with “City Speed Limits”
3. Replace all verbiage in 10.20.040 with the following:  
“It shall be unlawful for any person to drive or operate any motor vehicle on any street within the corporate limits of the city at a rate of speed faster than 20 (twenty) miles per hour (mph) except for the following: Southport Road between McFarland Road as the east boundary and Madison Ave as the west boundary, which speed limit has been established at 25 (twenty-five) mph; McFarland Road between Southport Road as the north boundary and Stop 11 as the south boundary, which speed limit has been established at 35 (thirty-five) mph; Stop 11 Road between McFarland Road as the east boundary and the railroad tracks as the west boundary, which speed limit has been established at 35 (thirty-five) mph; Madison Avenue from the south corporate line to the north corporate line, which speed limit has been established at 40 (forty) mph.
