**AN ORDINANCE TO AMEND THE CODE OF ORDINANCES OF THE CITY OF SOUTHPORT, INDIANA, TO
ADD A PROVISION TO ADOPT A FEE FOR THE COPYING OF LAW ENFORCEMENT RECORDINGS**

ORDINANCE NO. 16.08.03

WHEREAS, Ind. Code § 5-14-3-8 authorizes a public agency to assess a uniform fee, not to exceed one hundred fifty dollars (\$150), for direct costs involved in copying and disseminating a “law enforcement recording,” as defined by Ind. Code § 5-14-3-2; and

WHEREAS, the Common Council (“Common Council”) is the governing body for the City of Southport, IN (“City”) and is the proper body to establish such a fee; and

WHEREAS, the Common Council desires to adopt a fee of one hundred fifty dollars (\$150) for the copying and dissemination of a law enforcement recording.

NOW THEREFORE, BE IT ORDAINED by the Common Council that the following Section 4.16.040 shall be added to Title 4, Revenue and Finance, of the City of Southport Code of Ordinances:

CHAPTER 4:16

Police Department Fees

SECTION 4.16.040: LAW ENFORCEMENT RECORDING FEES

- (A) The City of Southport shall assess a fee in the amount of \$150 for copying and disseminating a law enforcement recording, as defined by Ind. Code § 5-14-3-2.
- (B) The Southport Police Department shall forward this administrative fee to the City Clerk-Treasurer, who shall deposit it into the Law Enforcement Continuing Education Fund.

FURTHER ORDAINED, that this Ordinance shall be in full force and effect from and after its passage, signature by the Mayor, and publication in accordance with the laws of the State of Indiana.
