**A RESOLUTION ELECTING TO PICK-UP MEMBER CONTRIBUTIONS TO THE 1977 POLICE OFFICERS' AND FIREFIGHTERS' PENSION AND DISABILITY FUND THROUGH SALARY REDUCTION**

**RESOLUTION 2017-16**

**WHEREAS**, the Southport Common Council is the governing body of the City of Southport in Marion County, Indiana; and

**WHEREAS**, the Common Council has previously adopted Resolution No. \_\_\_\_\_ electing to become a participating unit in the 1977 Police Officers' and Firefighters' Pension and Disability Fund ("1977 Fund") as administered by the Indiana Public Retirement System; and

**WHEREAS**, the State of Indiana has authorized covered employers to pick-up all or part of a member's mandatory employee contributions through a salary reduction.

**NOW THEREFORE, BE IT RESOLVED**, by the Common Council of the City of Southport, Indiana:

**SECTION 1.** The City of Southport elects to pick-up all of the mandatory contributions by employees who are members of the 1977 Fund through a salary reduction.

**SECTION 2.** That such contributions, even though designated as employee contributions for state law purposes, shall be paid by the City of Southport via a reduction in salary. Such contributions will not be included in the gross income of the employees for federal, state, or local income tax withholding, until distributed either through a pension benefit or a lump sum benefit.

**SECTION 3.** Such contributions will be included in the gross income of the employees for FICA taxes when they are made.

**SECTION 4.** All such contributions shall be made on a pre-tax basis but are paid through the employee through a payroll deduction.

**SECTION 5.** This election to pick-up mandatory employee contributions through a salary reduction shall be effective retroactively to January 1, 2017 if allowed by the Indiana Public Retirement System. Otherwise, this election to pick-up mandatory employee contributions shall take effect as of its adoption.
